La Dirección General Adjunta de Normatividad y Coordinación Sectorial, Unidad de Seguros, Pensiones y Seguridad Social, Subsecretaría de Hacienda y Crédito Público de la Secretaría de Hacienda y Crédito Público, mediante oficio 366-III-008/10 de 22 de enero de 2010, con fundamento en el artículo 36 del Reglamento Interior de dicha Secretaría, solicita a esta Comisión informe a esas instituciones y sociedades la actualización a la OFAC's SDN list respecto a la periodicidad indicada en la propia lista, realizada por la Oficina de Control de Activos Extranjeros (OFAC) del Departamento del Tesoro de los Estados Unidos de América, la cual puede encontrarse en la dirección electrónica:

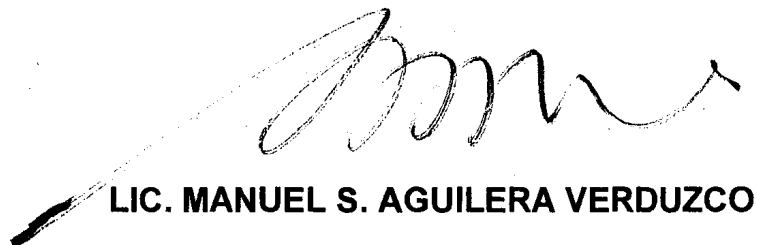
Por lo expuesto, se anexa al presente la actualización de referencia, solicitándoles lo siguiente:

- 1.- Reporten, por conducto de esta Comisión, a la Unidad de Inteligencia Financiera en términos de la regulación aplicable, aquellas transacciones que pudieran estar relacionadas con las personas, empresas y entidades de los países señalados en la actualización de referencia.
- 2.- En virtud de que las citadas personas, empresas y entidades de los países señalados, pudiesen estar vinculadas con la realización de operaciones con recursos de procedencia ilícita o de financiamiento de actividades terroristas, actualizar las hipótesis previstas en nuestra regulación aplicable para prevenir y detectar operaciones de lavado de dinero o de financiamiento al terrorismo que

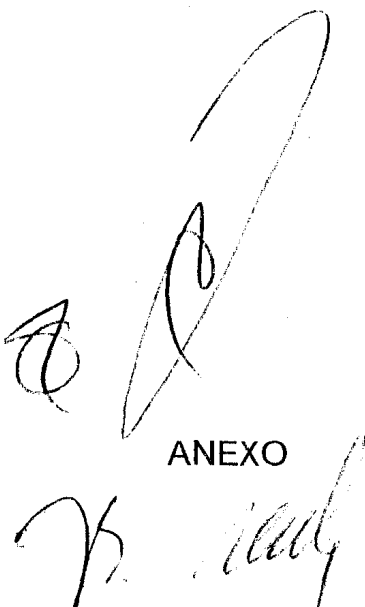
fueran consideradas como inusuales, en términos de las Disposiciones de Carácter General a que se refieren los artículos 140 de la Ley General de Instituciones y Sociedades Mutualistas de Seguros y 112 de la Ley Federal de Instituciones de Fianzas.

Lo anterior se hace de su conocimiento con fundamento en los artículos 108 fracción IV de la Ley General de Instituciones y Sociedades Mutualistas de Seguros, 68 fracción VI de la Ley Federal de Instituciones de Fianzas y de conformidad con el Acuerdo por el que la Junta de Gobierno de la Comisión Nacional de Seguros y Fianzas delega en el presidente la facultad de emitir las disposiciones necesarias para el ejercicio de las facultades que la ley le otorga a dicha Comisión y para el eficaz cumplimiento de la misma y de las reglas y reglamentos, emitido el 2 de diciembre de 1998 y publicado en el Diario Oficial de la Federación el 4 de enero de 1999.

New Federal Register notices with regard to Specially Designated Nationals or blocked entities may be published at any time. Users are advised to check the Federal Register and this electronic publication routinely for additional names or other changes to the listings. Entities and individuals on the list are occasionally licensed by OFAC to transact business with U.S. persons in anticipation of removal from the list or because of foreign policy considerations in unique circumstances. Licensing in anticipation of official Federal Register publication of a notice of removal based on the unblocking of an entity's or individual's property is reflected in this publication by removal from the list.
